## TERMS

Acceptance of all purchases on credit from Lannon Stone Products, Inc., Certified Truckers, and Moraine Development shall only be upon the terms and conditions set forth below. Any condition or different terms and conditions shall be objected to by Lannon Stone Products, Inc., Certified Truckers, and Moraine Development and shall be of no force or effect unless consented to in a signed writing from Lannon Stone Products, Inc., Certified Truckers, and Moraine Development.

- 1 Purchaser shall pay to Lannon Stone Products, Inc., Certified Truckers, and Moraine Development the full purchase price for all materials received from Lannon Stone Products, Inc., Certified Truckers, and Moraine Development within thirty (30) days of Purchaser's receipt of invoice for services or materials. Any portion of the purchase price unpaid after thirty (30) days shall immediately accrue interest at the rate of 18% annum. Purchaser shall be responsible and pay for all of the Lannon Stone Products, Inc., Certified Truckers, and Moraine Development costs and expenses, including reasonable attorney's fees incurred by Lannon Stone Products, Inc., Certified Truckers, and Moraine Development in enforcing any terms, conditions or provisions hereof.
- 2 Any charges requested by purchaser or Lannon Stone Products, Inc., Certified Truckers, and Moraine Development for services or materials, as the case may be, shall be effective and become part of the contract only by written agreement signed by both parties.
- 3 Lannon Stone Products, Inc., Certified Truckers, and Moraine Development shall not be responsible for any delays of its completion which are due to any act or neglect of Purchaser or Purchaser's agent or nominees, by change orders, by fires or other casualty, strikes, accidents, public authority, material or labor shortages, or any other cause beyond Lannon Stone Products, Inc., Certified Truckers, and Moraine Development's control.
- 4 Purchaser shall be responsible for and pay to Lannon Stone Products, Inc., Certified Truckers, and Moraine Development any Federal, State, or Municipal taxes for services and materials so purchased.
- 5 In the event purchaser fails to pay the full purchase price or other amounts required of the Purchaser hereunder when due and payable, or if Purchaser fails to observe, keep or perform any other provisions set forth hereunder as required by Purchaser, Purchaser shall be in default. Upon Purchaser's default, Lannon Stone Products, Inc., Certified Truckers, and Moraine Development shall be entitled to pursue any remedy at law or in equity against Purchaser, and all such remedies are cumulative and may be executed concurrently or separately, and exercise of any one remedy shall not be deemed to be an election of any other remedy.
- 6 No failure or delay on the part of Lannon Stone Products, Inc., Certified Truckers, and Moraine Development in enforcing any of the provisions hereof shall operate as a waiver as to any subsequent enforcement rights. The Purchaser hereunder shall be deemed to have been made in and by the laws of the State of Wisconsin. Any legal suit or action in regard to this contract shall be venued solely in Waukesha County Circuit Court, Wisconsin.
- 7 If any term hereof is prohibited by or deemed invalid under applicable laws or regulations, then such terms shall be deemed inapplicable and omitted but shall not invalidate the remaining terms hereof.
- 8 Pursuant to the credit policy of Lannon Stone Products, Inc., Certified Truckers, and Moraine Development all first time customers operating as a corporation or partnership are required to have officers, shareholders, directors or partners execute the following guaranty to ensure payment of Purchasers:
